* Space and over-crowding:

- Accommodation may be regarded as overcrowded if it is non-compliant with minimum recommendations outlined in any related Guidance. For example in section 2.2 of the Dog Breeding Guidance, if there are more dogs within a space than suggested on the grid, conditions could be considered as over-crowded.
- Allowance should also be made for breed size such that the minimum square metre noted would need to be adjusted to ensure that the dog can stretch etc without touching the sides of the kennel. Therefore, for a giant breed greater tolerance would be needed compared to smaller breeds.

In summary, an animal enclosure could be considered overcrowded if it failed the minimum criteria or the “stretch test”.

Vaccinations and Parasitic Treatments

Animals residing at the premises have up-to-date vaccinations and parasitic treatments administered at intervals specified by the manufacturer.

In the absence of an annual vaccination, satisfactory titre certificates are provided by the animal's vet.

For animals which are exempt from annual vaccination due to medical reasons such as adverse reactions, signed veterinary certificates confirming this, are available
