TOWN POLICE CLAUSES ACT 1847, SECTION 21

CITY OF PRESTON (LANCASHIRE ENCOUNTER FESTIVAL) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2022

WHEREAS

- (1) The Preston City Council is a local authority for the purposes of the Town Police Clauses Act 1847.
- (2) The Council is satisfied that vehicular traffic in the roads specified in this Order should be prohibited in the manner set out in the Order to prevent obstruction of the streets at a time of public celebration, namely the Lancashire Encounter Festival.

NOW THEREFORE the Council in exercise of the power contained in Section 21 of the aforesaid Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on the 17th day of September 2022 and may be cited as the City of Preston (Lancashire Encounter Festival) (Temporary Prohibition of Traffic) Order 2022.

Interpretation

2. In this Order:-

"the Council" means the Council of the City of Preston;

"Lancashire Encounter Festival" means a celebration of the spirit of diversity, creativity, innovation of the communities and businesses from across the county.

"vehicle" means a goods vehicle, a motorcycle, an invalid carriage, a motor vehicle, any other vehicle of any description whether drawn or propelled along a road by animal or mechanical power or a bicycle, or a tricycle or a cycle having four or more wheels.

3. For the periods specified in the First and Second Schedules to this Order no person shall, except upon the direction or with the permission of a police constable in uniform or the Director of Customer Services of the Council or her authorised representative, cause or permit any vehicle other than a vehicle forming part of or otherwise used in connection with the Lancashire Encounter Festival or an emergency service vehicle to enter, proceed, remain or wait in the length of roads

specified in the said First and Second Schedules on the days and between the times specified in the aforesaid First and Second Schedules.

4. The prohibition provided by Article 3 of this Order shall not apply if a police constable in uniform or the Director of Customer Services of the Council or her authorised representative determines that the prohibition is not required due to the progress of the event that is to be held on or near the said road.

THE FIRST SCHEDULE

PROHIBITION OF VEHICLES - 17th SEPTEMBER 2022

Orchard Street

- its full length.

Market Street

- between its junction with Orchard Street and its junction with Earl Street

The diversion route for the above mentioned closures will be via Earl Street, Lancaster Road, Church Street and Ring Way in that direction only.

The above-mentioned road closures are required between 8.00 a.m. to 4.30 p.m. on Saturday, 17th September 2022.

THE SECOND SCHEDULE

PROHIBITION OF VEHICLES - 18th SEPTEMBER 2022

Winckley Square (South) - its full length.

The diversion route for the above mentioned closure will be via Starkie Street and Ribblesdale Place in that direction only.

The above-mentioned road closure is required between 10.00 a.m. to 5.00 p.m. on Sunday, 18th September 2022.

The above-mentioned closures are necessary to prevent obstruction of the streets at a time of public celebration.
