18. Give full details of the ownership of the premises or the vehicle, vessel or stall including details of leases, tenancies, mortgagees, licences and any other interests.

19. Give full details of any alterations to be made to the structure or appearance of the premises or the vehicle, vessel or stall.

20. What are the proposed opening and closing times of the establishment?

21. How many persons are to be employed at the establishment?
