Introduction

Preston Community Safety Partnership recognises the reality of violence and the underlying risk factors identified by the Lancashire Violence Reduction Network's (LVRN) Needs Assessments. These will inform the actions and best practice included in this plan. The partnership will apply a public health approach, acknowledging that there is a growing body of evidence that violence is preventable.

The World Health Organisation (WHO) report on violence and health (2002) provided a comprehensive review of violence on a global scale and subsequently our understanding of the risk factors contributing to violence, those most at risk, its impact and the many preventative measures which have been informed by research, intelligence, and experience. The greatest impact is identified as occurring in the most deprived communities.

The cyclic nature of violence requires life course prevention strategies with an understanding that exposure to violence and other adverse experience in childhood increases the likelihood of being involved in violence when older. WHO identifies the factors for youth violence as individual factors, factors within close relationships and factors within the community and wider society (Figures 1a and 1b).

The LVRN's Needs Assessments include the best evidence from multiple reviews of the risk factors for serious violence. In conjunction with local analysis of serious crime and risk factors, the needs assessment has enabled the partnership to identify universal and targeted actions most suitable for local circumstances, for individuals and communities.

Following the publication of the Lancashire Strategic Assessment 2021, Preston Community Safety Partnership has also identified anti-social behaviour as a threat in Preston, in addition to serious violence offences. Even at low level, anti-social behaviour can be an indicator of factors leading to more serious violent offending and interventions to address the escalation of anti-social behaviour are part of a combination of measures to prevent serious violence. The partnership agreed to include a plan for anti-social behaviour as its statutorily required three-year Partnership Plan and to combine this with its serious Violence Plan, for the period up to March 2025.

This combined plan has been developed to provide a framework which will aid the delivery and achievement of intended outcomes to reduce the risks and improve protective factors for serious violence and anti-social behaviour. This will include a place-based approach in localities within the city where these have been identified in the LVRN Needs Assessments and other analysis, including heat mapping of local hot spots. Heat maps of priority wards were initially developed to inform planning and local intelligence is used to supplement this through the annual reviews.

The priorities for intervention in serious violence are taken from the Lancashire Serious Violence Reduction Strategy, which provides the overarching strategic guidance for the local community safety partnerships. The four priorities applied in the development of the plan are Prevention, Enforcement, Cultural Transformation and Evidence (Figure 3) and the plan remains a 'living' document which will be updated as information becomes available from analysis of local data.

The first part of the plan provides a place-based approach with some actions which are transferable to other neighbourhoods and communities and others which are bespoke to areas based upon their local profile. Part 2 focuses on children, families and communities, and Part 3 on actions to reduce serious violence, as defined in the Lancashire Serious Violence Strategy (Figure 3). Part 4 focuses on actions to reduce anti-social behaviour. The combined plan will be reviewed annually by the partnership's Community Safety Executive Group (CSEG) following agreement of the first version of the plan by the CSEG on 14th December 2021.

The published document incorporating the plan together with appendices will be updated annually. It will be available for public information on Preston City Council's website.

Delivery of actions will be the responsibility of the organisations of the partnership's Partnership Management Group (PMG) and other groups accountable within the governance structure or co-operating with Preston Community Safety Partnership either individually or collectively, as indicated in the plan. Membership of the PMG will be inclusive of statutory, voluntary, community, faith and private sector organisations providing services to local people or with an interest in reducing serious violence affecting individuals, families, or communities in the city.

Overall governance will be the responsibility of CSEG and progress with the planning and implementation of actions and the outcomes will be reported to the CSEG by the PMG.





Protective factors for serious violence


