

**LANCASHIRE COUNTY COUNCIL
HIGHWAYS ACT 1980
CLEAN NEIGHBOURHOODS AND ENVIRONMENT ACT 2005
(SAINTS AREA, PRESTON, PRESTON CITY)
(GATING) ORDER 2007**

The County Council of Lancashire, ("the Council") in exercise of its powers under **Section 129A** of the **Highways Act 1980** ("the Act") and of all other enabling powers, hereby makes the following Order:

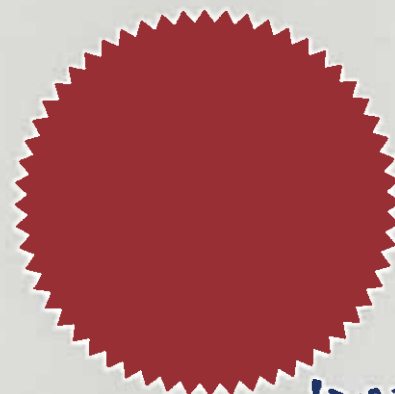
1. No persons, other than the owners, occupiers, statutory undertakers, or emergency services, shall have access to the alleyways (hereafter referred to as "the Highways"), or to keys to the gates restricting access to the Highways to the rear of: 172-266 St Thomas' Road, 13-107 St Stephen's Road, 2-100 Stephen's Road, 161-235 St George's Road, 232-276 St Paul's Road, 2-28 St Phillip's Road, 30-34 St Phillip's Road, 2-24 St Christopher's Road, 26-30 St Christopher's Road, 2-24 St Andrew's Road, 26-30 St Andrew's Road, 2-22 St David's Road, 26-30 St David's Road, 2-22 St Michael's Road, 24-28 St Michael's Road, 2-20 St Martin's Road, 22-26 St Martin's Road, 2-20 St Cuthbert's Road, 22-26 St Cuthbert's Road, 2-18 St Anthony's Road/269-283 Deepdale Road, and 289-303 Deepdale Road, Preston, in the City of Preston.
2. The alternative routes will be via St Paul's Road, St Thomas' Road, St Stephen's Road, St George's Road, St Philip's Road, St Christopher's Road, St Andrew's Road, St David's Road St Michael's Road, St Martin's Road, St Cuthbert's Road, St Anthony's Road and Deepdale Road.
3. The maintenance and operation of the gates will be the responsibility of The Director of Environmental Services, Preston City Council, Town Hall, Lancaster Road, Preston PR1 2RL (Contact tel. 01772-906523 Area Renewal Team).
4. It has been shown that anti-social behaviour and/or crime exists in the general area around the alleyway and this is exacerbated by the free access to the lengths of highway referred to above. The Gating Order would, by limiting access to only those persons indicated in Article 1 of this Order, be beneficial in tackling crime and/or anti-social behaviour in the area. The Council is therefore satisfied that the conditions set out in Section 129A(3) of the Act, have been complied with for the purposes of making this Order.
5. This Order shall come into force on the 6th day of August, 2007 and may be cited as the "Lancashire County Council, Highways Act 1980 Clean Neighbourhoods and Environment Act 2005 (Saints Area, Preston, Preston City) (Gating) Order 2007".

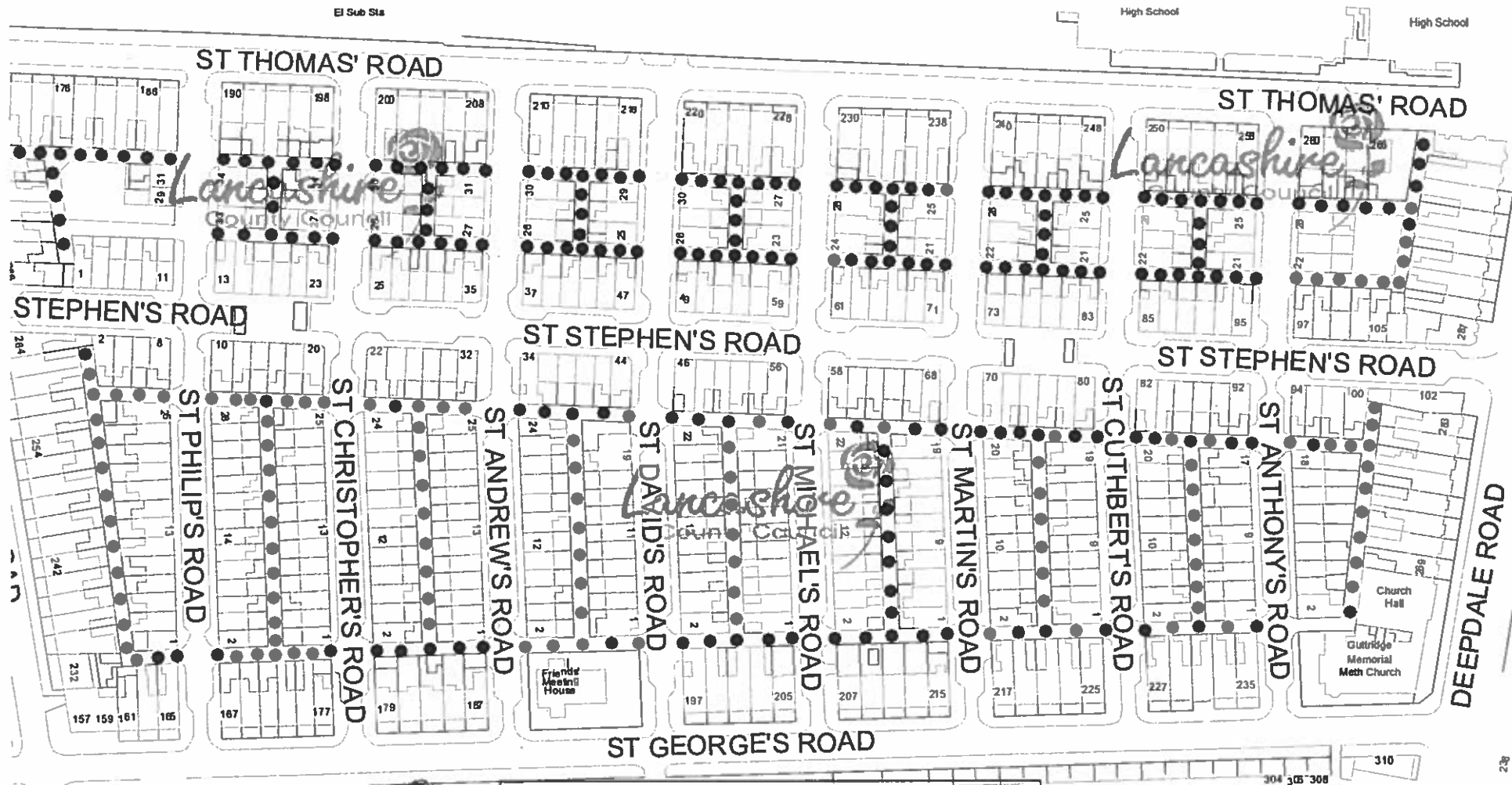
