## LANCASHIRE COUNTY COUNCIL HIGHWAYS ACT 1980 (TULKETH AREA 1, PRESTON, PRESTON CITY) (GATING) ORDER 2012

The County Council of Lancashire, ("the Council") in exercise of its powers under **Section 129A-129G** of the **Highways Act 1980** ("the Act") and of all other enabling powers, hereby makes the following Order:


- 1. No persons, other than the owners, occupiers, statutory undertakers, or emergency services, shall have access to the alleyways (hereafter referred to as the Highways), or to keys to the gates restricting access to the Highways: to the side of 100 Balcarres Road; the rear of 6 and 8 Grange Road; the rear of 3,5 and 7 Grange Road; the rear of 1-19 Rose Avenue; the side of 179 Inkerman Street; the rear of 177-139 Inkerman Street; the side of 159 Inkerman Street; the side of 137a Inkerman Street and the rear of 382 Blackpool Road (the Highways). The public right of way along these Highways is therefore restricted at all times.
- 2. The alternative routes are proposed as: via Inkerman Road; Lytham Road; Rose Avenue and Balcarres Road.
- 3. This Order authorises the installation of barrier to enforce the restriction of public rights. The maintenance and operation of the gates will be the responsibility of the Director of Environment Preston City Council Town Hall, St Paul's Road, Preston, PR1 1PX (Contact tel. 01772 906720 Operational Property Division).
- 4. It has been shown that anti-social behaviour and/or crime exists in the general area around the highways and this is exacerbated by the free access to the lengths of highway referred to above. The Gating Order would, by limiting access to only those persons indicated in Article 1 of this Order, be beneficial in tackling crime and/or anti-social behaviour in the area. The Council is therefore satisfied that the conditions set out in Section 129A (3) of the Act, have been complied with for the purposes of making this Order.

NOTICE OF PROPOSAL TO MAKE A GATING ORDER

NOTICE IS HEREBY GIVEN that the Lancashire County Council, ("the County Council") proposes to make a Gating Order under Section 129A-129G of the Highways Act 1980 (and all other enabling powers) in respect of the Highways to the side of 100 Balcarres Road, the rear of 6 and 8 Grange Road; the rear of 3,5 and 7 Grange Road; the rear of 1-19 Rose Avenue (odd numbers); the side of 179 Inkerman Street; the rear of 177-139 Inkerman Street; the side of 159 Inkerman Street; the side of 137a Inkerman Street and the rear of 382 Blackpool Road (the Highways).

The effect of the Order will be to restrict the public right of way over the Highways at all times. The Order will authorise the erection of barriers to enforce this restriction. Certain people will be excluded from the effects of the restriction and may have keys to the gates erected.


